Unit 1 Blackstone's Skills for Success

Unit 2 Torts

Conversion and its many aspect, the concept of legal cause, negligence, and deceit are all explained. This lesson also considers defamation, who may sue or be sued for defamation, and the wrongs that may interfere with domestic, contractual, and business relations. Additionally, right of privacy, liability, joint wrongs and relationships are discussed.

Unit 3 Criminal Law

This unit explores the broad subject of criminal law, beginning with the different meanings, how circumstances affect criminal responsibility, and the physical and mental elements necessary for an act to be a crime. You will read about the several rights of defense and degrees of participation in criminal acts, as well as the classifications of crime. You will also be informed on offenses against the person, offenses against the habitation, and offense against property, in addition to embezzlement, false pretenses, receiving stolen goods, and malicious mischief.

Unit 4 Pleadings and Practice in Civil Actions, Criminal Procedure

You will study pleadings in civil actions, which build on the necessity of pleading and the steps that are taken during court proceedings for both plaintiffs and defendants. The lesson discusses the proceedings of a civil trial, as well as the appeal process. Grasp what criminal procedure means and how it differs from a civil action, in addition to how a criminal trial proceeds from beginning to end.

Unit 5 Critical Thinking Skills

Develop your critical thinking skills, expanding your use of inference and judgment, identifying strong conclusions, persuasive strategies, and deductive reasoning. Other sections include metacognition, the process of thinking about thinking, and how it builds critical thinking skills, as well as interpreting and using critical theories.
