You can log in to your account by clicking **Student Login** from the bottom of the <u>blackstone.edu</u> home page or go to <u>https://online.blackstone.edu/login/index.php</u>



To log in, enter your username and password. Your username will be the email address you used to enroll with Blackstone. A temporary password was sent to you in your *New User Account* email. Please use this temporary password for your initial log in. You will then be prompted to change your password.

After you have logged in, you will be in **BCI Homeroom**. This page will give you news and links to access your course. You may access **My Courses** from the top menu bar or in the middle of the homepage. **Resources** will give you information to help you through your course. Other options include **Make A Payment, Student Profile, and Contact BCI.**
