CRIMINAL LAW

The predominance of criminal law cases within the legal system has caused an increasingly high demand for paralegals trained in this field. Blackstone's Criminal Law advanced paralegal course introduces students to the criminal justice system and its components as well as their multifaceted role as a paralegal. The accompanying e-textbook, *Fundamentals of Criminal Practice: Law and Procedure* presents the principles of criminal law and the paralegal's role in criminal proceedings. This correspondence course explores the basic principles of criminal law, the types of offenses, and criminal procedure from the commission of the offense to trials and their aftermath. The prosecutor's role in initiating cases and the role of the defense attorney in defending the accused are discussed. Along with the importance of pre-trial motions and plea bargaining, this course also covers homicide, assault and battery, arson, burglary, embezzlement and extortion.

IMMIGRATION LAW

Blackstone's immigration law advanced paralegal course provides an overview of immigration and nationality law in the United States, with an emphasis on its practical application in a law firm, non-profit legal service agency or corporate environment. Students will learn about employment, family-based visas, along with the law concerning refugee protection, asylum, policies affecting certain vulnerable populations and the citizenship process. Students will learn specialized paralegal skills including client interviewing, communication, form completion and file organization with an emphasis on attention to detail and deadlines. Students will develop research skills and discover resources to obtain up-to-date information in immigration law. Students will analyze the factors involved in shaping or changing immigration policies and laws.

REAL ESTATE LAW

Representation of real estate clients is a major area of practice for many law firms. Therefore, opportunities for real estate paralegals are numerous. Blackstone's Real Estate Paralegal course covers the elements of real property; different methods used in recording and describing deeds; transference of title; rights associated with real estate ownership; elements of real estate contracts; basic landlord/tenant law; deeds, mortgages, and restrictions on land use; title insurance and title examination; the closing process; and tax implications of real estate transactions. The e-textbook that accompanies this course; *Real Estate and Property Law for Paralegals* includes figures, tables and sample forms to provide visual aids for learning; annotated documents that focus on relevant sections of actual legal documents; case excerpts; and highlights of the specific skills students will need as real estate paralegals.

WILLS, TRUSTS, & ESTATES

FAMILY LAW

PERSONAL INJURY & TORTS

INTERVIEWING & INVESTIGATING

No case can be won without a quality investigation. Often times the preliminary investigation is performed by a paralegal – the result of which can play a key role in the client’s perception of the attorney, the firm, and the case. Blackstone’s Interviewing & Investigating advanced paralegal course provides an overview of interviewing and investigating skills used by paralegals to gather relevant information to assist the legal team in case preparation. The e-textbook, *Interviewing & Investigating: Essential Skills for the Paralegal* presents formal discovery as it relates to civil and criminal litigation. This course also includes ethical considerations that affect the interviewing and investigating process. Students will learn to identify and find witnesses, use public and private sources of information, and prepare and conduct interviews of clients and witnesses.
